Sergeant DeFelice,  
Thank you for a response to my request for a confirmation of receipt of the material sent to you.

I think that it is important for you to know that despite the fact that there is a camera, placed by DCF in the house in which Scott [REDACTED] lives with his biological daughter's, no one seems to observe the tapes.

Scott [REDACTED] "patted" Elizabeth's buttock, eliciting a response from her, to which Scott [REDACTED] responded "OOPS.....No one is going to do anything anyway",..... and they haven't.

You have not heard the tape of Ethel Moore 's interview..... The girls verify every statement made in writing and articulate fears of being murdered by Scott; they are of course interviewed separately by her. Ethel Moore is the caseworker who referred to [REDACTED] as a "lying cutter". Complaints against Ethel were ignored by Tim Welch, her supervisor, who supported Ethel's lack of "bias and competence". A viewing of the tape will speak for Ethel Moore's competence.

There are multiple episodes on the video tape in the [REDACTED] residence where [REDACTED] says to Scott "I hate you", Scott just laughs.

As of Sun. 6/5/16 Scott said to Elizabeth and [REDACTED] " just wait till DCF closes the case....."

Please be advised that all material being sent to you is part of the process of preserving evidence against all complicit in placing the lives of [REDACTED] and Elizabeth [REDACTED] in jeopardy, as well as facilitating, supporting, prolonging the suffering to which they have been subject as a result of the collusion of Eric Frazer, Jacob Pyetranker, DCF, the Ct. Board of Education, Police Chief DeMayo, of the New Canaan Police Department .... since 2011, and others to be listed in their individual capacity.

If anything happens to [REDACTED] and Elizabeth [REDACTED] before they can be rescued from the situation of malicious false imprisonment , the extensive evidence in our possession will be forwarded to the proper authorities, which do not include any manner part or form of the DCF bureaucracy which is entirely complicit in the top to bottom mishandling of this case and so very many others.

Despite reporting, in writing to every level of the DCF bureaucracy and state legislators, who report back to DCF, the girls have received no relief at all and in fact – as per the Ethel Moore interview, their risk has been compounded and their suffering increased. I can provide evidence of their suffering as well. I can also provide evidence of reporting to all levels of “child protection services” and their absence of any appropriate response.
