AFFIRMATION OF EXPERT

I, MONTY WEINSTEIN, PSY.D., M.p.A., D.A.p.A., and N.C.p.,
affirm the following:

1. I am a Clinical Fellow of the American Association for
Marriage and Family Therapy. This association is utilized
by the American Academy of Matrimonial Attorneys. I am a
Fellow of the American Orthopsychiatric Association, an
association composed of psychologists and psychiatrists

throughout the United States. In addition, I have been qualified as an expert in custodial issues, parental alienation issues, domestic violence, deliverance of mental health services, abuse and neglect, management of psychiatric facilities, coercive psychiatry and dispute resolution over 2,500 times in 45 states and 4 countries.

2. I am an Adjunct Professor and have been utilized by major law firms throughout the country. In addition, I am the recipient of the Distinguished Public Service Award.

3. Besides holding two masters and a doctorate, I have over 1,000 hours of certification at the Cambridge Institute and Harvard University. I was also commended by the Governor of the State of New York and other dignitaries for my children serving their country. I have an earned doctorate which was recognized by the United States Department of Education and, in addition, was chartered in the State of Wisconsin.

4. I am certified in dispute resolution by the New York State Unified Court System and recognized by Chief Judge Judith Kaye. I have taken advanced training at Fordham Law School and other law schools in family mediation.

5. I am on the editorial advisory board for the American Psychotherapy Association. I have spent the last five years editing psychiatric and psychological manuals for publication in the national journal which is utilized throughout the United States. Also, besides being a gatekeeper for various manuscripts being published, I have also published numerous book reviews for the American Orthopsychiatric Association in the area of social justice and scientific reliability and validity.

6. Further, for several years, I chaired the ethics committee in a psychiatric facility, and I have published at least fifty journal articles in the area of mental health. I have also been on national television and have studied the scientific validity of the deliverance of mental health services at New York University graduate school of public affairs. I was a clinical administrator for years at a large children's psychiatric facility in Florida.

7. My partner for ten years was a Dr. Robert Gould, MD, who was chief of psychiatry at Bellevue, and a full professor at New York Medical College, Cornell. I have done at least sixty assessments for him.

8. I developed my expertise on the deliverance of mental health services by editing the psychiatric journal, reviewing book reviews, studying clinical administration at New York University, and being a clinical administrator at psychiatric facilities for numerous years.

9. All my works that I have published have been peer reviewed.

10. I am also involved in veteran affairs and have been on national television.

11. This case involves the clinical administration and psychological expertise.

12. Because of some of the egregious acts by state bureaucrats which I am familiar with by my activities in other-cases which I have testified on, the state players are trying to put a psychiatric cloud over Jill Jones' license without any psychiatric or psychological probable cause.

13. They know very well that if they give her a psychiatric label, she would have to walk on water in order to regain her license.

14. Cases I have worked on where there was an extreme element of confidentiality were in fact revealed on the website of the Department of Health.

15. Further, the same stooges from the New York Psychiatric hospital that have been investigated numerous times for egregious ethical acts are the gatekeepers in creating psychiatric manifestations.

16. I have done research on coercive psychiatry and I am on the Board of Directors of the Network Against Coercive Psychiatry with such eminent scholars as Dr. Peter Bragen, former United States attorney general Ramsey Clarke, Dr. Seth Farber and formerly Dr. Robert Gould who was my associate and partner.

17. Clinical Administration is learned by years of experience directing psychiatric facilities, editing psychiatric manuals for publication working numerous years with the American Orthopsychiatric Association and publishing numerous peer review articles by the American Psychotherapy Association.

18. The force of my affidavit is predicated not only on my psychological expertise, but in the reality that I have been involved as the director of the family therapy center and president of the National Parent's Rights Association out of Georgia. I have written numerous amicus curiae briefs in the courts of the United States.

19. I am actively involved in this case at this point because of my reviewing New York State Department of Health's horrific bureaucratic group of individuals who have a zealous "fervor" to take out anyone who does not go along with their political agenda. They usually do that by putting psychiatric labels to individuals which instantly takes away their constitutional rights.

20. They are under the impression that some of the psychiatrists have judicial immunity ad infinitum. If one would read the New York Times lately, one could see the failure of many psychiatrists and psychologists from New York State and other leading places who have failed to disclose their alliances with pharmaceutical companies for personal profit and advantage.

21. Before entering this case, I had extensive talks with quality assurance experts in Jill Jones' respective

field from Columbia University. I have also had extensive talks with experts in educational law from Harvard University. I have also had extensive conversations with other leading attorneys who are affiliated with National Parents Rights Association from Harvard and other leading institutions.

22. There is a witch hunt against Jill Jones which is tantamount to performing capital punishment on an individual who may have or have not jay-walked.

23. Depriving Jill Jones of her license is depriving hundreds of poor minority patients of their rights to regain their children in the courts of New York.

24. Within this play, the state has coerced Jill Jones into a conference with the under the guise that there would be some form of an administrative settlement when in reality there was a pseudo mental status examination so they could find a reason to put a psychiatric label on her for no probable cause.

25. Jill Jones is a sensitive nurturing matriarchal individual who has taught at Columbia University physicians and surgeons, has a graduate degree from Hunter College in

psychiatric social work and an MPH from Touro University International. Has helped numerous parents around the country. Is the executive director of a foundation and has written extensively in the area of divorce and dispute resolution.

26. The bureaucrats of the state in my opinion have to be held accountable for this complicitous witch hunt against a fine, brilliant and mature and creative therapist who has spend twenty thirty seven years helping individuals in distress.

I hope and pray that I will get to opine on this egregious coercive and duplicitous witch hunt by state players who are practicing coercive psychiatry to remove Jill Jones' license: a creative individual who has challenged some of the egregious acts practiced by other professionals in her field.
