I am Jill Jones Soderman Executive Director of FCVFC.ORG.

I am a psychoanalyst, psychotherapist and a forensic expert.

The experts associated with the FCVFC are very familiar with the multiple atrocities committed by Judge Maritza Martinez. Multiple cases / clients have successfully sought our expert assistance . Unfortunately I am currently aware of a case that has come under the destructive, vile control of Judge Martinez who has had the poor judgment to ignore the psychiatric forensic expertise of Dr. Bandy Lee MD.

I am fortunately able to independently access all necessary information I require to follow cases that some personnel attempt to hide under color of law.

Judge Martinez will not be able to hide from public scrutiny and most meaningfully, she will not be able to hide from criminal prosecution.

It has come to my attention once again that Judge Maritza Martinez has acted in a manner that places the lives of young children and vulnerable protective parents in grave danger.

The evidence presented in multiple cases before Judge Maritza Martinaz reaches a level that places children in a position of being beyond child endangerment, to potential murder by medical neglect and abuse. Further, there are cases before Judge Martinez that involve acute sexual abuse, endangering young girls with the prospect of pregnancy in a world where proper medical intervention for pregnancy is no longer available.

A series of articles being published under the heading "When Mommy is My Sister And Grandpa is My Dad" document pregnancy and birth imposed on children ages five and eleven years old. Judge Martinez endangers the lives of children, whether turning them into parents, deranged criminals driven mad because of not being able to evade abuse, or simply dismantling their psyches. By imposing the life long memories and experiences of incomprehensible terror and physical pain that interferes with such things as academic functioning and healthy social functioning necessary to a DEMOCRATIC society.

One such potential victim successfully evaded the criminal collusion and lawlessness of Judge Martinez. The success involved in legally managing that case has been fully documented with Press exposure that secured the credibility of the work of the FCVFC.

I, as the Executive Director of the FCVFC / a mandated Reporter and established WhistleBlower, cases that come before me endangered by any judge who violates the rights to protection of vulnerable children and Protective Parents want you to be absolutely clear that my organization will be seeking pursuit of all action available to seek proper litigation on behalf of victims and prosecution of all culpable of interfering in the protection of subject parties.

Experts of the FCVFC will be filing complaints and seeking investigation with all relevant state agencies and authorities including the State Prosecutor's Office and the State legislature. Review of potential tax fraud charges will also be raised as per tracking Federal funding under Title IV D and Title IV E.

Complaints brought to your attention with regard to Judge Martinez unconscionable cruelty, disregard for her fiduciary responsibility, much less constitutional accountability was disregarded . As a result of your own disrespect for the welfare and safety of those under your purview, you will be included in the criminal and civil complaints with full documentary support for the crimes being committed under Color of Law in your court.

Judge Martinez is under the impression that falsely jailing litigants and seeking to impose GAG orders may have a sufficiently chilling effect to protect her and your exposure. Be abundantly clear that fully documented evidence will be reported to the Press to make sure that there is public reporting on the atrocities being committed as part of the WHISTLEBLOWER function of the FCVFC which has been well reported on the FCVFC.ORG website.
